## BEST (Business Exchange and Student Training)

- **Mission:** To foster competition and the entrepreneurial high-tech culture in Italy via a transfer of US best practices through an exchange program with Silicon Valley
- Program modules: 1. 3 months of classes in the Santa Clara University to study entrepreneurship 2. Each student works for 3 months in a start-up in Silicon Valley 3. After the repatriation<sup>(\*)</sup>, students are supported for 6 months by an Italian tutor to launch the start-up
- Scholarship: tuition fees + travel + housing + monthly allowance + health insurance
- ▼ Target: Bachelor degree, PhD students (<35 yo) with high-tech ideas
  </p>
- Actors: USA Embassy in Italy, Fulbright Commission, INVITALIA, Italian Consulate in SF, Fondazione CRT
- **Donors:** (each scholarship is worth Euro 35,000): Enel, Fondazione CRT, Fondazione Banco di Napoli, RDS, Innogest, Pegaso, US Embassy, Regione Emilia

#### **Results**

- 87 winners
- 37 high-technology start-ups created in Italy
- € 50 mln of financing for the start-ups
- € 9.5 mln of overall sales volume
- 320 people involved, of which 125 in Ghana

(\*) Grantees enter the USA with a J1 Visa whereby they must come back and cannot be employed in the US for the subsequent 2 years



## One Week Accelerator Program New York

- Allow Italian start-ups with expansion goals in the United States to know and interact with the venture-capital ecosystem of Manhattan
- The program lasts an intense one week and allows each start-up to meet the key value chain players
- IB&II launched this initiative in May 2011 and organizes these meetings twice a year (Spring, Autumn)
- IB&II has partnered with VenureOutNY a New York based accelerator

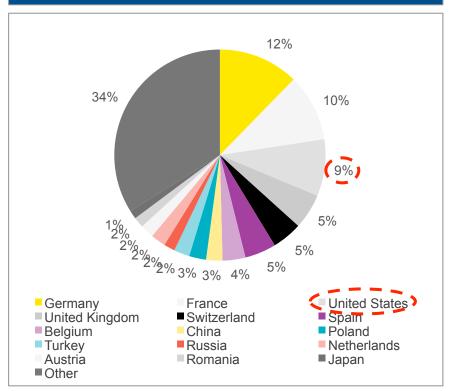

# Role of Italy in the world trade

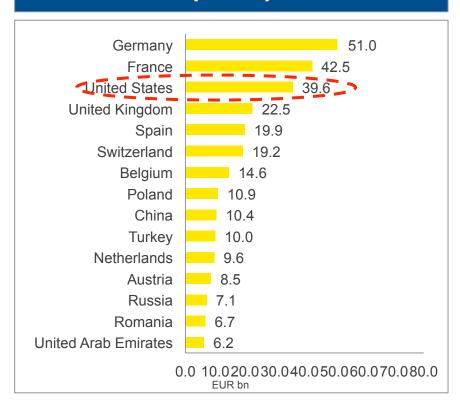


# 66% of Italian exports was addressed to 15 main trading partners

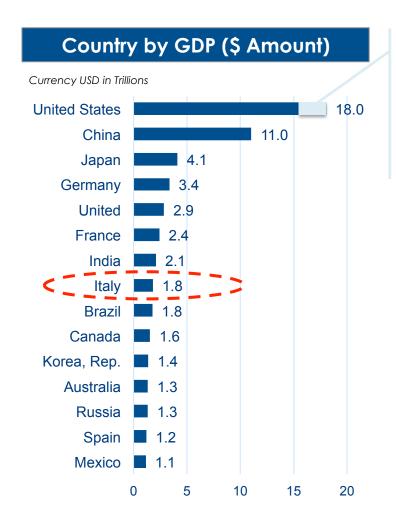
# Italy's top exports 2015 by value (EUR bn)





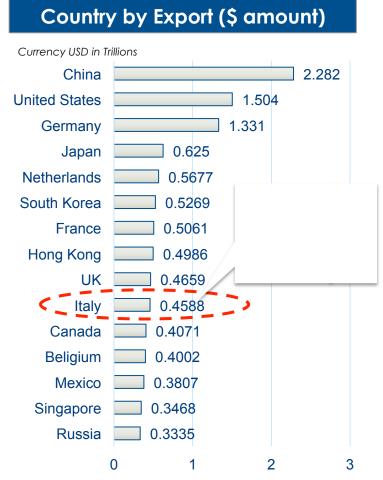
# Where does Italy rank in the world?
